

BOLTZ VOLLEYBALL FINANCIAL COMMITMENT: 2026-2027 Club Volleyball Season

In order for Boltz Volleyball Club to execute its annual plan, we must adhere to our budget. If a family decides to voluntarily withdraw from the club for personal reasons or is removed for violation of USAV and/or Boltz Volleyball Club rules, they will be responsible for the balance of their dues. Once you sign your player contract, you are committed to the season with the Boltz Volleyball Club. Should you withdraw before the season is over; you will not be entitled to any refunds of money already paid and any balance due will be billed to the financially responsible parent/guardian. A player that voluntarily withdraws or is removed from the team involuntarily, for any reason, has 60 days to pay all remaining fees. Players also have 60 days from the last tournament to pay all remaining fees before they will be moved into collections. Failure to complete the payment schedule as agreed upon by the player contract can render the athlete ineligible to compete with Boltz Volleyball Club until the balance is paid in full. It should also be noted that it is USAV AZ Region Club policies that players that are not in good standing with their previous clubs will not be allowed to participate in subsequent seasons for any club until they are in good standing. Any season dues not paid 60 days after withdraw or 60 days from the last tournament date for your team will be put into collections and billed a collection fee of \$300. These will be then submitted to small claims court. Under no circumstances should coaches collect money for payment of dues and/or fees. All payments are to be made online or to the club Director/Business Manager. Circumstances that prevent a player from participating (injury, schedule, conflict, suspension, etc.) do not dismiss the financial obligation to the club.

TEAM DUES & PAYMENT SCHEDULE

Members have the option of paying for the entire season up front (ON THE DAY OF TRYOUTS) and will receive a \$100 off discount for doing so at the time of team assignment acceptance. Monthly payments are due by the 1st of each month. Any payment received after the 1st of the month will be considered "late" and a late fee of \$5 each day the payment is not received, will be applied to the balance. Any checks returned due to insufficient funds will be charged a \$50.00 returned check fee plus late fees. All fees and late charges must be paid prior to the player participating in any future practices or tournaments. Boltz Volleyball Club will accept online payment through the website. A deposit is required on signing day. If the need arises, and special payment arrangements become necessary, Boltz Volleyball Club will do everything possible to assist in such arrangements. If a special payment arrangement is needed, please send a request, in writing, to the Club Director/Business Manager explaining the specific installment amounts and dates of payment. The Club Director will send a written response with an addendum contract to be signed by the applicant if the payment structure request is approved.

Financial Commitment: I acknowledge that my child has been selected to participate in club volleyball @ BOLTZ VOLLEYBALL and will abide by AZ Region/USA Volleyball & AAU rules and policies. I acknowledge that I have registered my child with the AZ Region/USA Volleyball & AAU and we are committed to the Boltz Volleyball Club from commitment date through July 31st 2027. I hereby financially commit to the FULL DURATION of the club season and the amount identified above for my child's team. (FULL DURATION is defined as Commitment Date through the end of USAV/GNJC/Festival). Post season teams and coaching assignments may be adjusted based on team need at BOLTZ director's discretion (athletes who qualify for GJNC are "frozen" to that team's roster). I hereby agree to abide by, and acknowledge I have read the BOLTZ Handbook and Code of Conduct for the 2026-2027 season. (Boltz Handbook and code of conduct can be located at www.boltzathletics.com). I understand that if my child is removed from or withdraws from participation FOR ANY REASON, voluntarily or involuntarily, before the completion of the child's assigned team's scheduled season, all pre-paid monies will be forfeited. Additionally, any remaining balance must be paid within 60 days of child's withdrawal/removal from BOLTZ volleyball. I additionally commit to making monthly payments as outlined above, on or before the 1st of the month. Any alternative payment plan must be in writing and approved by the BOLTZ director in advance. Payments not received by the 1st of the month are subject to late fees outlined above. Delinquent Accounts: Athletes will be required to sit out of all BOLTZ activities until the account is brought into good standing. To receive a \$100 off discount, full payment must be made ON THE DAY OF TRYOUTS.
